- N/A - Upon termination of board service, Common Units representing limited partnership interests may be purchased on the open market on behalf of Mr. Jenkins-Stark whereby he would receive Common Units in a number equal to the number of Deferred Share Units ("DSUs") recorded in his account less any applicable withholdings. Alternatively, Mr. Jenkins-Stark may elect to receive the value of his DSU entitlement in cash. The cash payment amount shall be determined by multiplying the number of DSUs recorded in his account by the Fair Market Value of a Common Unit less any applicable withholdings.
- N/A - the DSUs are fully vested and are redeemable only following Mr. Jenkins-Stark's termination of Board service.
- Mr. Jenkins-Stark elected to have a portion (50%) of his annual retainer paid in the form of DSUs in lieu of cash. The number of DSUs is calculated based on the Fair Market Value of the Common Units representing limited partnership interests.
